**PUBLICATION POLICY/ APPLICATION TO PUBLISH**

**NEW JERSEY HISTORY ROOM MATERIALS**

The Red Bank Public Library, in order to support research and scholarship on the history of New Jersey, will consider requests to publish materials from its special collections. The Red Bank Public Library reserves the right to restrict publication, and in certain cases, to deny requests. Publication will be denied in cases where the Librarian is aware that the library does not own copyright or where reproduction will damage the material. Publication may also be denied for any other reason the Library Director deems valid. Publication may be allowed under the following conditions, to which the researcher agrees by signing this application:

- 1) I agree to assume all legal responsibility for observing copyright law, the laws of libel, and invasion of privacy, and property rights.
- 2) I will cite the specific special collection as the source of the information or image and the Red Bank Public Library as the owner of the original material. The citation should read: Name of Collection, "Red Bank Public Library."
- 3) In cases where the Red Bank Public Library does not hold copyright, I understand that I must obtain such permission from the copyright holder as well as from the Red Bank Public Library.
- 4) I agree not to make additional copies of this material.
- 5) I understand that permission to publish is not transferrable.
- 6) I understand that permission is granted for one-time publication only.
- 7) I agree to contribute to the library two (2) free copies of any publication or published book.
- 8) I agree to pay for one scanned copy at a cost of \$10.00 per image.
- 9) I agree to pay the Permission to Publish charge in the amount of \$25.00 per image.
- 10) Total cost for Permission to Publish in the amount of \$35 per image, plus the postage and handling fee, where applicable, is to be paid in advance and to accompany the completed Reproduction Request Form.
